2. **Private Sector Transportation Spotlight: UPS Innovation and Urban Delivery** *Frank Morris, UPS*
Frank Morris, UPS Public Affairs, will discuss innovative ways UPS is making deliveries, as well as some of the challenges with urban deliveries. UPS has announced they will begin deploying electric delivery trucks in Atlanta and two other cities nationally. With the growth of e-commerce and increasing density in activity centers throughout the region, alternative fuels and other innovations will be key to managing this growth in the future.
