What's in Amendment #6

- Main purpose - time sensitive financial adjustments ahead of major 2020 RTP update
- General cost estimate increases to federal-aid projects beyond threshold for an administrative modification
- Changes to MMIP projects - cost estimates and addition of state (HB170) funding
- Funding ongoing activities in support of the 2020 RTP update

- 10-day Public Comment Period - October 15 to October 24
- Committee and Board Action
 - TCC - November 9
 - GRTA Board - November 14
 - TAQC - November 15
 - ARC Board - December 5
- Submit documentation to US DOT (FHWA & FTA) and US EPA for approval - November 15
- Conformity Determination expected mid to late December

 - Other time-sensitive changes to modeling for conformity projects ahead of RTP update
 - 2nd Quarter 2019 adoption timeframe
- RTP Update/FY 2021-2026 TIP

 - Early 2020 adoption timeframe
