- **Human Services Transportation Plan Update**
 - *Discussion:* Sam (Henry Co) asks presenter Kenyata Smiley (HNTB) what has changed in the region over the last 15 years between HST plans. Kenyata answers that services have expanded, but the population is outpacing that service growth. Housing cost is dictating where people can live, and that impacts her access to HST services. There were multiple questions about the wording used on the survey including: if Uber/Lyft rides were included as transportation options, if cars were included as a transportation option, and that the overall language around HST is confusing. Kenyata answered that Uber/Lyft was included via an "Other/fill in the blank" survey choice and that cars were included in different questions than what was shown in the presentation.
