TCC Meeting Minutes

Actions

- **2024 Atlanta Regional Freight Mobility Plan**
 - *Motion:* Henry County

First Read

- **MTP/TIP Amendment**
 - *Discussion:* Sam (Henry Co) asks why the list of projects wasn't included in the presentation. Jean Hee (ARC) said that all project details will be available for review in amendment packet and that this presentation was to provide an overview of what was included.

Information

- **Regional Medium and Heavy-Duty Fuel Efficiency Plan**
 - *Discussion:* Sam (Henry Co) asks about difference between biodiesel and renewable biodiesel. Sade (ARC) explains that both are biomass, and biodiesel is animal fats and recycled gas while renewable biodiesel uses different chemical processes to combine similar components. Sade (ARC) offers to provide details on the chemical compounds used in renewable biodiesel if requested. Michael (ARC) asks about schedule for the plan. Sade (ARC) says it will be started in the next month or so and asks TCC members if there are specific fuel types they would like to see studied and included in the plan.
- **Transportation Forum Update**
 - *Discussion:* Sam (Henry Co) adds that he really wants to hear presentations from fellow TCC members on what they're working on and that it shouldn't just be the GPA conference when he hears from other TCC members. Eleanor (ARC) answers that the Forums are a great place to highlight work happening in different localities and encourages TCC members to contact her to present or host future Forums. asks about what a site visit would mean. Eleanor (ARC) explains it could be a tour of a completed project and asks for TCC members to contribute what they think a site visit should and could look like for the Forums.
