- I. Welcome Romona Jackson-Jones
 - o Co-Chair, Romona Jackson Jones, called the meeting to order at 1:00pm.
- II. Public Comment Period Romona Jackson-Jones, Co-chair
 - o No registered public comment was recorded.
- III. Committee Roll Call Becky Kurtz
 - Roll Call of Board Members was taken by Atlanta Regional Commission (ARC) staff, Becky Kurtz, Managing Director, of Aging & Independence Services Department.
 - Quorum was present.
- IV. Managers Update Becky Kurtz, Managing Director
 - o Aging & Independence Services 2023 Initiatives
 - Explore partnerships with health care payers to expand service populations
 - Dependent on funding availability and federal/state policy decisions
 - Improve Workflow Efficiencies
 - Aging and Disability Resource Connection (ADRC) staff reorganization to improve customer responsiveness/efficiencies
 - o Implement "Live Beyond Expectations" Strategic Framework
 - Complete Community Engagement activities in all 10 counties
 - Analyze learnings and determine strategies towards implementation • Expand service provision
 - Utilizing COVID-19 grants

- FY 23 State Aging Services Grant Amendments
 - Recent new awards:
 - Culturally appropriate information and assistance

- o CO-AGE 2023 Priorities
 - HCBS Funding
 - Status On Thursday, March 9th, the House passed their FY 2024 budget, HB 19. They allotted \$5,464,800 for Home and Community Based Services! This is a \$1 million increase from last year!
 - Improvements to Assisted Living Communities
 - Issue -Current laws prohibit Medicaid funding to residents in Assisted Living and large Personal Care Home facilities.
 - Ask Remove restrictions against Medicaid benefits in Assisted Living Communities and larger Personal Care Homes.
 - Status The CO-AGE advocacy team is in talks with the Georgia Department of Community Health, which oversees Medicaid, to determine what direction to take regarding the improvements to assisted living communities' priority.
 - Teledentistry
 - Ask The Georgia Council on Aging (GCOA) and the Coalition of Advocates for Georgia's Elderly (CO-AGE) recommends that legislation to establish Teledentistry under the umbrella of Telehealth will benefit those who have little to no access to oral care in rural areas as well as in remote settings (outside of the dental office), such as long-term care communities, hospitals, domestic violence shelters, community clinics, and the home bound.
 - Status The Teledentistry bill, HB 441, was not heard during Crossover but the bill sponsors are still discussing how best to move the legislation forward. The advocacy team is on standby for their recommendations.
 - Work and Save
 - Ask Legislation would create the state-run program for caregivers and working Georgians to have an opportunity to



offer employees a benefit of a retirement savings. The Georgia Council on Aging (GCOA) and the Coalition of Advocates for Georgia's Elderly (CO-AGE) recommends that legislation be passed to create a formal Work and Save program for the state of Georgia.

- Status While the Work and Save bill did not make it through Crossover, significant progress has been made in introducing the concept of Work and Save to the Georgia Legislature.
- Federal appropriations (Federal Fiscal Year 2023) FY23 started October 1, 2022
 - Appropriations bill passed December 20, 2022
 - O Slight increases to these funds that come to the AAA:
 - Older Americans Act
 - Supportive Services (IIIB)
 - Congregate Meals (IIIC-1)
 - Home Delivered Meals (IIIC-2)
 - Wellness Education (IIID)
 - Family Caregiver (IIIE)
 - Falls Prevention Education (ARC has applied)
 - AmeriCorps Seniors
- Selecting a new co-chair


A. Live Beyond Expectation – Arin Yost

Research + Community Engagement Fellow (Lead for America)

- Regional Strategic Plan 2020 2025.
- Identify and address the inequities that create disparities in life expectancy



- Engage with regional, state, and national stakeholders to bolster current partnerships
- Develop new relationships and collate existing and new resources to support a long-term vision that all who live in the Atlanta region can lead long and healthy lives no matter where they live.
- o Life expectancy in Sandy Springs/Vinings is 87.6 years and is 63.8 in the Bankhead/English Avenue area of Atlanta.
 - That's a 24-year difference.





ARC's Aspirations with LBE

- Identify and reduce inequities that create disparities in life expectancy and quality of life
- Build organizational and community awareness of disparities
- · Build capacity to address disparities
- Long-term aspiration: Bring lower life expectancy areas up to the regional average life expectancy and improve quality of life along the way

Approaches to Reduce Disparities

- Practice: provide services and programs that address unmet needs
- Policy: work with governmental, philanthropic, educational, nonprofit, and business leaders to improve or amend policies that create inequities and advance policies that promote equity
- Place: focus on locations, within each county, where residents experience the most inequity

Implementation To-Date

- Inventoried ARC work programs and alignment opportunities
- Researched factors impacting life expectancy and disparities between high and low life expectancy tracts

- Mapped baseline of how ARC-funded services overlap with lower life expectancy areas
- Convened advisory committee of internal ARC staff and external partners (ongoing)
- o Annual Process Evaluation & Nex Steps
 - o Summarize qualitative & quantitative data
 - Convene existing partners, residents, and coalitions
 - Co-design and implement intervention strategies based on community's priorities
 - o Implementation task milestones completed
 - Output measures related to strategies by location

- Foundational document for ARC's Aging & Independence Services as the "Area Agency on Aging" (AAA)
 - 10-county metro area
- 4-year plan for delivery of aging services
 - Required by the federal Older Americans Act
 - · Contains statedetermined goals, objectives, and measures for serving older persons
 - Each AAA develops strategies to meet these goals, objectives, and measures







 - One "multi-funded" grant made up of numerous federal and stateaging servicesgrants
 - For the State Fiscal Year (July 2023- June 2024)
- ARC provides update to DAS on its progress on the Plan's goals
