CCSP: Community Care Services Program

- Medicaid waiver operated by AAAs in GA, under contract with DHS since program began in early 1980's.
- Program is moving from DHS to DCH July 1, 2016.
- Program has been under a freeze since February 2015 (one enrollment per region, per month— 12 enrollments statewide).
- DCH contract will be very similar to previous contracts for 1 year (7/2016 to 6/2017).
- ARC currently receives approx \$5,000,000 each year to serve 10 county area.
- DCH has indicated they plan to make changes for Jul 2017:
 - Move from annual grant to monthly fee per client
 - Separating intake/screening from care coordination
 - Merge CCSP with SOURCE program by Dec 2017
