Transportation Improvement Program FY 2020-2025, Amendment #2 Public Review 01/14/21 – 02/11/21

The Transportation Improvement Program (TIP) is the mechanism by which federal, state and local funds are approved for all significant surface transportation projects and programs in the region. The FY 2020-2025 TIP comprises the first six years of the Regional Transportation Plan (RTP) for the Atlanta region. As the federally recognized Metropolitan Planning Organization (MPO) for a 20-county region, ARC is responsible for developing and amending/updating the TIP and RTP to meet federal planning requirements and address local needs.

Purpose of Amendment

- Include the programming of new funding recommendations from the 2019 TIP solicitation
- Address project cost estimate and programmatic changes that are of a time sensitive nature or cannot be handled administratively.

An email was sent to ARC's interested parties distribution list indicating the TIP Amendment was open for public review. Details regarding the amendment project list, process, and timeline were posted on ARC's website. Additionally, the request for review was advertised via the Fulton Daily Report and Mundo Hispanico. Information was also shared through various ARC newsletters and presentations.

Public Comment Summary

ARC received two written public comments submitted via email and one public comment submitted verbally at the February 10th public hearing prior to the Transportation and Air Quality Committee. The summary of the comments received are provided in this document. This document, along with specific comments will be shared with ARC Transportation Coordinating and Transportation & Air Quality Committee members, as well as all appropriate regional transportation project sponsors. ARC Response

Thank you for your comment regarding the Memorial Drive corridor. At this time, a project is not currently identified in the Transportation Improvement Program (TIP) for the Memorial Drive corridor and DeKalb

County has not requested improvements to be included in the TIP. Projects listed in the TIP are included at the request either by the Georgia Department of Transportation (GDOT) or the project sponsor. However, since Memorial Drive is a state road, GDOT will need to be involved with any planning and design work. Therefore, if a future project is identified for the Memorial Drive corridor and federal funds are designated for the project, ARC will be notified by the appropriate project sponsor (GDOT or DeKalb County) for inclusion in the TIP.

In 2014, DeKalb County did develop a Comprehensive Transportation Plan (CTP) which identified improvements along Memorial Drive as a recommendation for future improvements. DeKalb County will be undergoing an update of their Comprehensive Transportation Plan with community meetings forthcoming in the near future. Recommendations from such plans are used to submit project fund requests and inclusion in the TIP by the county. ARC encourages ongoing participation in community meetings as it relates to this corridor.

Public Comment #3 (given at public hearing on February 10, 2021):

In regards to the plans for pedestrian infrastructure along Fulton Industrial, as a former resident of the area, increased pedestrian infrastructure such as crosswalks, pedestrian traffic lights, as well as bus shelters and benches would increases the walkability especially at the intersection of Camp Creek Parkway and Fulton Industrial. Residents expressed a need for safety and walkability which is lacking in South Fulton especially along these major roads. A simple increase of sidewalks could propel the area to being more safe for walking and bike riding. There has been an increase of warehouses being built in the area and it makes it difficult to commute without sidewalks, crosswalks, etc. The intersection of Camp Creek and Fulton Industrial holds a lot of potential, but without accessibility and walkability, the area will become increasingly less safe for pedestrians.
