### **Background**

- Priority for metro Atlanta region
- Reduce traffic congestion and improve safety
  - Improvements to I-285/SR 400 Interchange
  - Improvements to approaches
- Benefit from existing assets
  - revive285 environmental studies
  - SR 400 environmental approval & acquired right-of-way



### **Background**

- Design-Build-Finance (DBF) delivery method
  - Maximize use of available funding
    - Some payments through construction period
    - Private financing beyond the construction period
  - Accelerate delivery
  - Utilize innovative construction and MOT methods
  - Minimize impacts to traveling public



#### **Scope**

### • P.I. # 0000784

- EB and WB CD lanes -Roswell Rd to Ashford-Dunwoody
- NB and SB CD lanes –
  Glenridge to Hammond
- Reconstruct ramps and bridges through the SR 400 interchange
- Construct shared-use path in SE quadrant





### <u>Scope</u>

- P.I. # 721850-
  - NB and SB CD lanes -Hammond to north of Spalding
  - Replace Mt. Vernon overpass
  - Convert Abernathy Rd.
    interchange to a Diverging
    Diamond Interchange (DDI)





### <u>Scope</u>

- Technical provisions for DBF project procurement
  - P.I. # 0000784 I-285/SR 400 Interchange
    - New EA/FONSI approved May 19, 2015
    - GDOT acquire "core" ROW by December 31, 2016
    - Developer will acquire "outside" ROW
  - P.I. # 721850- SR 400 Collector-Distributor Lanes
    - Re-evaluation of EA/FONSI approved on May 21, 2015
    - GDOT acquire all remaining ROW by June 30, 2016
- DBF project construction under P.I. # 0013546



### **Project Status**

### **Procurement**

- Open until after financial close
- Apparent Best Value Proposer
  - Announced on December 10, 2015
  - North Perimeter Contractors (NPC)
    - **Contractor** Ferrovial Agroman US Corp
    - Engineers Louis Berger Group (70%), Neel-Schaffer (30%)
    - NPC has International and United States experience
  - Bid Amount \$459,949,588



### **Project Status**

#### **Procurement**

- Programmed Total Project Cost \$1.058 million
  - Estimated Payments to Developer \$838 million
    - During Construction \$337 million (to 2020)
    - Developer Financing \$501 million (2020 to 2025)
  - Estimated Agency & Right of Way Costs \$220 million
- NPC's bid saves more than \$200 million in total project payout



## **Project Status**

#### **Procurement**

- Actual Total Project Cost \$803 million
  - DBF Contract Amount/Payments to Developer \$460 million
  - Agency Costs \$97 million
  - Right of Way Cost \$148 million
  - Various Contingencies \$97 million
- Final payment sooner than anticipated 2025
- Cost savings will be recognized at the end of the project
