1. Welcome / Acceptance of October 13th TAQC Meeting Summary / Public Comment period

Charlotte Nash, TAQC Vice Chair, welcomed the group and noted that the committee did not have a quorum today. Chairman Nash asked if there were any comments on the draft 10/13/2016 TAQC Meeting Summary, and hearing none, declared the summary accepted as previously distributed. There was no public comment.

2. Action Item: 2017 Unified Planning Work Program

The Atlanta UPWP is developed annually and documents metropolitan transportation planning activities performed with federal, state, and local transportation funds in the 20 county Atlanta region.

Haley Berry, ARC, gave a brief overview of the UPWP and the purpose of that document to capture the agency's planning and project work for 2017. She noted key items for next year's workplan, including a truck parking study and a bike/ped safety action plan. Berry highlighted that GDOT and FHWA have reviewed a draft of the UPWP without comment and will approve the final document once it is adopted.

Without a quorum the action item was referred to the ARC Board (for action on December 7, 2016) without a recommendation from TAQC.

3. PDTF Action Plan Update

Patrick Bradshaw, ARC, gave a brief overview of ARC project delivery measures, including TIP phase implementation rates from FY 2003-2016, and upcoming TIP project delivery reporting efforts. He explained the need for better project delivery reporting for both regional outcomes and meeting federal reporting requirements.

Any Goodwin, ARC, provided an update on the Project Delivery Task Force Action Plan. She reviewed the action items developed in 2015 and provided a brief update on actions completed or underway. Brian Allen, ARC, provided a brief update on ARC's pending funds reprogramming policy to allow ARC staff to move funds that won't be used onto projects that need funding support. Goodwin concluded with a discussion of how deliverability criteria will impact the upcoming TIP solicitation in 2017.

4. Update on Regional Trail Inventory

Byron Rushing, ARC, gave a brief presentation on the status of a Regional Trail Report to quantify the benefits of a regional trail network. A critical next-step will be assessing the existing, programmed, and planned trail segments throughout metro Atlanta. Rushing reviewed the current regional trail inventory and asked for feedback on locations and status of trail projects as well as guidance on trial planning policy.

Mike Houchard, Rockdale County, asked for clarification about the cost benefit calculations presented. Rushing explained that these are cost benefit calculations that show dollar figures related to trail implementation.

5. Other Items

TAQC members provided updates on the status of SPLOST and TSPLOST votes in the region, including Gwinnett County, City of Atlanta, Fulton County, and MARTA.

 future iterations of this survey.
