1. Welcome – Acceptance of October 22, 2019 TDMCC Meeting Summary, Public Comment Period

Roz Tucker, ARC, asked if there were any changes to the October 22 meeting summary. Upon hearing no comments, the summary was accepted as presented. There were no public comments.

2. Equity in TDM Outreach

Joddie Gray, UrbanTrans, presented on approaching equity in TDM program design, implementation, and outreach. Focusing on how data and personal stories can be used to contextualize the region's mobility needs, she emphasized that TDM programming must not only demonstrate a commitment to and an understanding of equity, but also intentionally include a process for addressing equity. Some strategies discussed included identifying businesses that employ traditionally underserved communities as well as developing data-driven solutions that connect workers to site-specific transportation needs.

3. Administrative Items (Drawing for Terms & Committee Selections)

Jill Goldberg, ARC, led the drawing for terms, whereby each committee member selected a term limit of either 2 or 3 years at random. Jill Goldberg drew terms for any members who were not in attendance and called them out to the committee. A list of committee member term limits can be found among the meeting materials. Additionally, Jill Goldberg directed the committee members to fill out a sheet indicating which, if any, of the four subcommittees they would have an interest in serving on. The subcommittees are: Technology, Research and Policy, Marketing and Communications, and Equity.

4. Atlanta TDM Plan

Shayna Pollock, CAP, presented on the TDM policies and priorities outlined in the Atlanta Transportation Demand Strategy (2019), a local strategy document developed by Central Atlanta Progress in partnership with Midtown Alliance and Livable Buckhead. The document explores local policies and strategies that can be pursued by the City of Atlanta to promote TDM, including zoning codes, a parking tax, and commuter benefit ordinance.

5. TDMCC 2020 and Announcements

Roz Tucker, ARC, noted that in 2020 several RFPs will be issued, including one for GCO employer services and outreach and another for updated regional TDM plan. Priorities for the 2020 regional TDM plan will be discussed in further detail at the February 18 meeting, at which time the committee will also vote to adopt the charter.
