Research and Data Initiatives

- Continued work on new Series 16 Regional Forecasting Process for The Atlanta Region's Plan Update (targeted adoption of Spring 2020); held process review meeting with Technical Advisory Group (TAC) Committee Chair, followed by TAC meeting #2 in late August; began scheduling of small-area forecast input/ review meetings from September to December 2018.
- Published major jurisdiction population estimates for 2018 via various internet and social media channels; assisted in press release development and did multiple interviews with many print, radio, and television media outlets.
- Neighborhood Nexus continued work on yearlong Robert Wood Johnson 500 Cities project (Neighborhood Health
 and Wellness Toolkit); refined WebApp; selected (via data committee) specific health indicators for focus in project
 areas; began identification of secondary data sources to inform selected health indicators; developed revised draft
 schedule for outreach activities in target cities.
- Initiated Neighborhood Nexus project phase II work for Junior League of Atlanta and continued collaborative development a Resource Development Plan to enable further data literacy outreach efforts in the future.
- Completed assistance to Department of Community Affairs and local governments for Census 2020 Local Update of Census Addresses. (LUCA); began planning for assistance with/ participation in the Participant Statistical Areas Program (PSAP) program in later 2018/ early 2019

• Provided data and analysis for Regional Leadership Initiative (RLI) 2018; spatial data and mapping for the More MARTA effort; forecast data for the area in and around the City of Dunwoody program; custom data for the Atlanta Journal and Curbed Atlanta; estimate consultation with Fulton County Schools; and fulfillment of "out of region" data requests from Ford Motor Company and the Washington (DC) Council of Governments.

Transportation Initiatives

- The Regional Bicycle and Pedestrian Safety Action Plan Draft Resolution was approved by TCC, TAQC, and the ARC Board in August.
- Continued coordination and assistance on CTP updates in Fayette County, Forsyth County, Clayton County and Rockdale County. Monitored final approval process for City of Atlanta CTP update. Finalized RFP for southern Fulton County CTP, with release scheduled for September 10. Finalized subgrant agreement with Cobb County for their CTP update and the county released their RFP on August 30.
- Continued coordination with GDOT and ARC committees on federal performance-based planning target setting and documentation requirements. Efforts in August continued to focus on requirements associated with pavement/bridge condition, travel time reliability, congestion and emissions reduction targets. ARC must act on targets for those measures by November.
- Began formal review of The Atlanta Region's Plan Policy Framework in anticipation of next major RTP update due in early 2020. Also initiated internal review of revenue assumptions and forecasts.
